ABSTRACT

Granite Construction Company currently operates a portable aggregate processing plant in Morgan, Utah, under AO DAQE-AN2727004-06, dated July 3, 2006, and temporary relocation letter DAQC-376-09, dated April 8, 2009. Granite Construction Company has requested to make this a permanent site. The plant will produce up to 750,000 tons of aggregate per year. A diesel generator will supply power to the plant. A dispersion modeling analysis was performed for PM₁₀, and the predicted total concentration was found to be less than its respective NAAQS.

The plant is located in Morgan County, which is an attainment area of the NAAQS. 40 CFR 60 Subparts A, OOO, and IIII, and 40 CFR 63 Subparts A and ZZZZ apply to this source. 40 CFR 61 regulations do not apply to this source. Title V of the 1990 Clean Air Act applies to this source, and this source is considered a Title V Area Source.

The potential to emit totals for the plant, in tons per year, will be as follows: PM₁₀ = 12.67, NO_x = 28.45, SO₂ = 0.88, CO = 36.95, VOC = 1.16, HAPs = 0.01.

The NOI for the above-referenced project has been evaluated and has been found to be consistent with the requirements of UAC R307. Air pollution producing sources and/or their air control facilities may not be constructed, installed, established, or modified prior to the issuance of an AO by the Executive Secretary of the Utah Air Quality Board.

A 30-day public comment period will be held in accordance with UAC R307-401-7. A notification of the intent to approve will be published in the Ogden Standard Examiner on October 3, 2009. During the public comment period the proposal and the evaluation of its impact on air quality will be available for the public to review and provide comment. If anyone so requests a public hearing, it will be held in accordance with UAC R307-401-7. The hearing will be held as close as practicable to the location of the source. Any comments received during the public comment period and the hearing will be evaluated. The proposed conditions of the AO may be changed as a result of the comments received.

Section I: GENERAL PROVISIONS

- I.1 All definitions, terms, abbreviations, and references used in this AO conform to those used in the UAC R307 and 40 CFR. Unless noted otherwise, references cited in these AO conditions refer to those rules. [R307-101]

- I.2 The limits set forth in this AO shall not be exceeded without prior approval. [R307-401]
- I.3 Modifications to the equipment or processes approved by this AO that could affect the emissions covered by this AO must be reviewed and approved. [R307-401-1]
- I.4 All records referenced in this AO or in other applicable rules, which are required to be kept by the owner/operator, shall be made available to the Executive Secretary or Executive Secretary's representative upon request, and the records shall include the two-year period prior to the date of the request. Unless otherwise specified in this AO or in other applicable state and federal rules, records shall be kept for a minimum of two (2) years. [R307-401]
- I.5 At all times, including periods of startup, shutdown, and malfunction, owners and operators shall, to the extent practicable, maintain and operate any equipment approved under this AO, including associated air pollution control equipment, in a manner consistent with good air pollution control practice for minimizing emissions. Determination of whether acceptable operating and maintenance procedures are being used will be based on information available to the Executive Secretary which may include, but is not limited to, monitoring results, opacity observations, review of operating and maintenance procedures, and inspection of the source. All maintenance performed on equipment authorized by this AO shall be recorded. [R307-401-4]
- I.6 The owner/operator shall comply with R307-150 Series. Inventories, Testing and Monitoring. [R307-150]
- I.7 The owner/operator shall comply with UAC R307-107. General Requirements: Unavoidable Breakdowns. [R307-107]

II.A The approved installations shall consist of the following equipment:

- II.A.2 **One (1) Horizontal Impact Crusher**

II.B Requirements and Limitations

II.B.1 **The Morgan Aggregate Plant shall be subject to the following**

II.B.1.a Granite Construction Company shall notify the Executive Secretary in writing when the installation of the equipment listed in this AO has been completed and is operational. To ensure proper credit when notifying the Executive Secretary, send your correspondence to the Executive Secretary, attn: Compliance Section.

If the owner/operator has not notified the Executive Secretary in writing within 18 months from the date of this AO on the status of the construction and/or installation, the Executive Secretary shall require documentation of the continuous construction and/or installation of the operation. If a continuous program of construction and/or installation is not proceeding, the Executive Secretary may revoke the AO. [R307-401-18]

II.B.1.b The aggregate processing plant shall not produce more than 750,000 tons of aggregate material per rolling 12-month period. [R307-401-8]

II.B.1.b.1 To determine compliance with a rolling 12-month total the owner/operator shall calculate a new 12-month total by the twentieth day of each month using data from the previous 12 months. Records of production shall be kept for all periods when the plant is in operation. Production shall be determined by belt scale records and/or scale house records. The records of production shall be kept on a daily basis. [R307-401-8]

II.B.1.c The owner/operator shall conduct its operations during the months of March through August from 6:00 a.m. to 10:00 p.m., during the months of September through November from 6:00 a.m. to 8:00 p.m., and during the months of December through February from 8:00 a.m. to 5:00 p.m. [R307-401-8]

II.B.1.c.1 Records of hours of operation shall be kept for all periods when the plant is in operation. Hours of operation shall be determined by supervisor monitoring and maintaining of an operations log. [R307-401-8]

II.B.1.d Unless otherwise specified in this AO, the owner/operator shall not allow visible emissions from any source on site to exceed 20 percent opacity. [R307-201-3]

II.B.1.d.1 Unless otherwise specified in this AO, opacity observations of emissions from stationary sources shall be conducted according to 40 CFR 60, Appendix A, Method 9. [R307-201-3]

II.B.2 **All Crushers on site shall be subject to the following**

II.B.2.a The owner/operator shall not allow visible emissions from any crusher on site to exceed 12 percent opacity. [40 CFR 60 Subpart OOO]

II.B.2.b The owner/operator shall install water sprays or a baghouse on all crushers on site to control emissions. Water sprays shall operate as required to maintain the opacity limits listed in this AO when the temperature is above freezing. The owner/operator may stop the water sprays when the temperature is below freezing. [R307-401-8]

II.B.3 **All Screens on site shall be subject to the following**

II.B.3.a The owner/operator shall not allow visible emissions from any screen on site to exceed 7 percent opacity. [40 CFR 60 Subpart OOO]

II.B.3.b The owner/operator shall install water sprays on all screens on site to control fugitive emissions. Sprays shall operate as required to maintain the opacity limits listed in this AO when the temperature is above freezing. The owner/operator may stop the water sprays when the temperature is below freezing. [R307-401-8]

II.B.4 **All Conveyors on site shall be subject to the following**

II.B.4.a The owner/operator shall not allow visible emissions from any conveyor transfer point on site to exceed 7 percent opacity. [40 CFR 60 Subpart OOO]

II.B.4.b The owner/operator shall not allow visible emissions from any conveyor drop point on site to exceed 20 percent opacity. [R307-205-4]

II.B.4.c The owner/operator shall install water sprays on all unenclosed conveyor transfer points on site to control fugitive emissions. Sprays shall operate as required to maintain the opacity limits listed in this AO when the temperature is above freezing. The owner/operator may stop the water sprays when the temperature is below freezing. [R307-401-8]

II.B.5 **All Crushers, Screens, and Conveyors on site shall be subject to the following**

II.B.5.a The owner/operator shall conduct an initial performance test for all crushers, screens, and conveyor transfer points on site within 60 days after achieving the maximum production rate but not later than 180 days after initial startup. Performance tests shall meet the limitations specified in Table 3 to Subpart OOO. Records of initial performance tests shall be kept and maintained on site for the life of the equipment. [40 CFR 60 Subpart OOO]

- II.B.5.a.1 Initial performance tests for fugitive emissions limits shall be conducted according to 40 CFR 60.675(c). The owner or operator may use methods and procedures specified in 40 CFR 60.675(e) as alternatives to the reference methods and procedures specified in 40 CFR 60.675(c). [40 CFR 60 Subpart OOO]
- II.B.5.a.2 The owner/operator shall submit written reports to the Executive Secretary of the results of all performance tests conducted to demonstrate compliance with the standards set forth in 40 CFR 60.672. [40 CFR 60 Subpart OOO]
- II.B.5.b The owner/operator shall perform monthly periodic inspections to check that water is flowing to discharge spray nozzles in the wet suppression system associated with the aggregate processing plant. If the owner/operator finds that water is not flowing properly during an inspection of the water spray nozzles, the owner/operator shall initiate corrective action within 24 hours and complete corrective action as expeditiously as practical. [40 CFR 60 Subpart OOO]
- II.B.5.b.1 Records of the wet suppression system inspections shall be kept and maintained in a logbook for all periods when the plant is in operation. The records shall include the following items:
 - A. Date the inspections were made
 - B. Any corrective actions taken
 - C. Control mechanism used if sprays are not operating. [40 CFR 60 Subpart OOO]
- II.B.6 **The Stationary Diesel Generator shall be subject to the following**
- II.B.6.a The stationary diesel generator shall not exceed 3,000 hours of operation per rolling 12-month period. [R307-401-8]
- II.B.6.a.1 To determine compliance with a rolling 12-month total, the owner/operator shall calculate a new 12-month total by the twentieth day of each month using data from the previous 12 months. The records of operation shall be kept on a daily basis. Hours of operation shall be determined by supervisor monitoring and maintaining of an operations log. [R307-401-8]
- II.B.6.b The owner/operator shall not allow visible emissions from the stationary diesel generator to exceed 20 percent opacity. [R307-201-3]
- II.B.6.c The sulfur content of any diesel fuel burned in the stationary diesel generator shall not exceed 0.05 percent by weight. [40 CFR 60 Subpart IIII]
- II.B.6.c.1 The sulfur content shall be determined by ASTM Method D2880-71, D4294-89, or approved equivalent. Certification of diesel fuel shall be either by the owner/operator's own testing or by test reports from the diesel fuel marketer. [R307-203]

II.B.7 **All Haul Roads and Fugitive Dust Sources on site shall be subject to the following**

II.B.7.a The owner/operator shall not allow visible emissions from haul roads and fugitive dust sources on site to exceed 20 percent opacity at all times. [R307-205-4]

II.B.7.a.1 Visible emission determinations for fugitive dust emissions from haul-road traffic and mobile equipment in operational areas shall use procedures similar to Method 9. The normal requirement for observations to be made at 15-second intervals over a six-minute period, however, shall not apply. Visible emissions shall be measured at the densest point of the plume but at a point not less than 1/2 vehicle length behind the vehicle and not less than 1/2 the height of the vehicle. [R307-205-4]

II.B.7.b The hours of operation for all bulldozers at the facility shall not exceed 3,000 hours combined per rolling 12-month period. [R307-401-8]

II.B.7.b.1 To determine compliance with a rolling 12-month total, the owner/operator shall calculate a new 12-month total by the twentieth day of each month using data from the previous 12 months. The hours of operation of each bulldozer shall be added together to determine the total hours. Hours of operation shall be determined by supervisor monitoring and maintaining of an operations log. [R307-401-8]

II.B.7.c The owner/operator shall cover all unpaved haul roads and wheeled-vehicle operational areas with road base material and shall use water application to maintain opacity limits listed in this AO. If the temperature is below freezing, the owner/operator may stop applying water to the unpaved haul roads and wheeled-vehicle operational areas. The owner/operator shall resume applying water to the unpaved haul road and wheeled-vehicle operational when the temperature is above freezing. [R307-401-8]

II.B.7.c.1 Records of water application shall be kept for all periods when the plant is in operation. The records shall include the following items:

- A. Date and time treatments were made
- B. Number of treatments made and quantity of water applied
- C. Rainfall amount received, if any
- D. Records of temperature, if the temperature is below freezing. [R307-401-8]

II.B.7.d The owner/operator shall comply with all applicable requirements of R307-205 for Fugitive Emission and Fugitive Dust sources on site. [R307-205]

II.B.8 **All Drilling and Blasting Operations on site shall be subject to the following**

II.B.8.a The owner/operator shall install and use a shroud on all aggregate drills when drilling to control fugitive emissions. [R307-401-8]

- II.B.8.b The owner/operator shall not conduct more than 38 detonations per rolling 12-month period. [R307-401-8]
- II.B.8.b.1 To determine compliance with a rolling 12-month total, the owner/operator shall calculate a new 12-month total by the twentieth day of each month using data from the previous 12 months. Number of detonations shall be determined by supervisor monitoring and maintaining of an operations log. [R307-401-8]
- II.B.8.c The owner/operator shall not use more than 152 tons of explosives per rolling 12-month period. [R307-401-8]
- II.B.8.c.1 To determine compliance with a rolling 12-month total, the owner/operator shall calculate a new 12-month total by the twentieth day of each month using data from the previous 12 months. Amount of explosives used shall be determined by purchasing records and/or maintaining an operations log. [R307-401-8]
